

A statement has been released referencing the tragic event that took the life of 14-year-old Gavin Knupp.

The statement references Mr. Ralph DeAngelus, who is a local business owner and partner with Matt Ortt Companies LLC.

We do not have any additional information about this incident other than what has been posted and shared.

Update 8:05 PM - Many questions have come in about why certain people can't view this post any longer. I checked it out, and it appears that Matt Ortt Companies LLC has removed the original post. Therefore, the original post is no longer able to be viewed.

The following is the text quoted from Mr. Matt Ortt's original post on Facebook from earlier today.

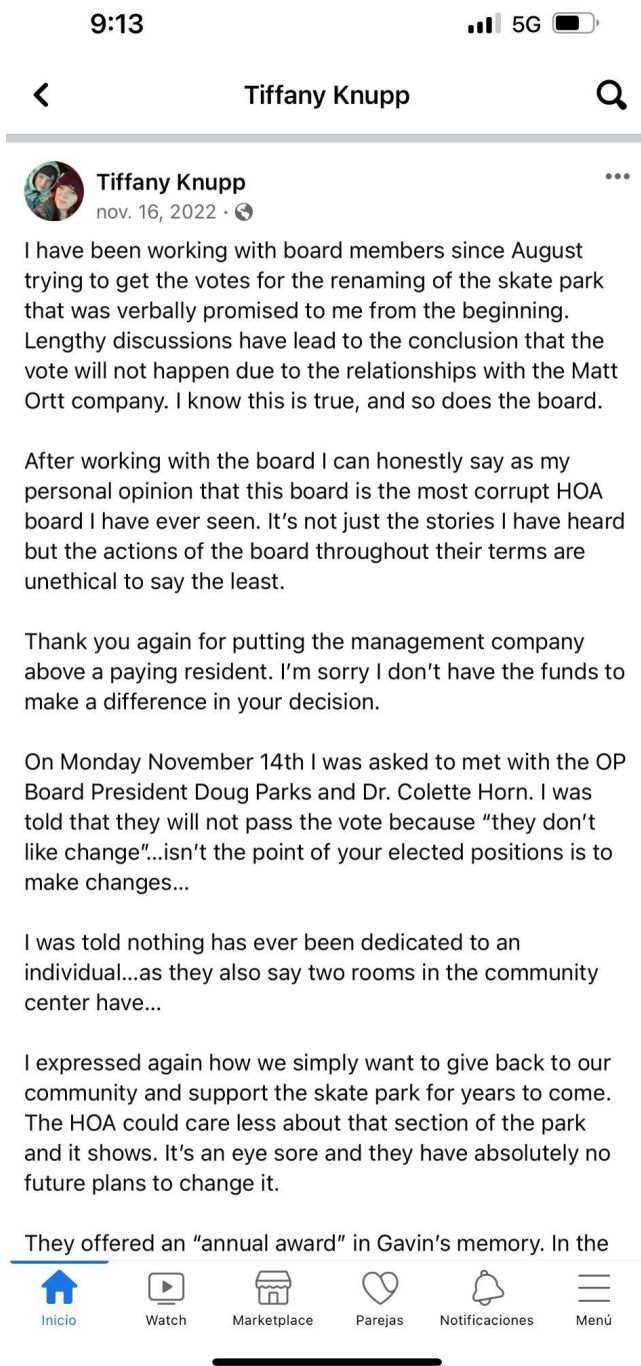
"On behalf of Matt Ortt Companies, we are aware of a tragic event that has brought pain and heartache to multiple families and our thoughts are with all of those involved. With all of the speculation surrounding this event, I feel the need to say something publicly. I have been in business with Ralph DeAngelus for three decades as a leader, mentor, and partner. During that time, Ralph has always been a man of integrity, which is how he has built such a stellar reputation in our town. Over the past few years, Matt Ortt Companies has added substantially to the area by revitalizing the Ocean Pines food and beverage operations and starting two new popular restaurants, all of which employ over 400 members of this community. At this time, my focus will be to continue to operate Matt Ortt Companies to the same high standards to which we have always held ourselves. For obvious reasons, Ralph cannot speak about this matter. However, he has said to me directly: "In the end, the truth will come out, and it will prove me to be the man you always thought I was." I will take him, as I always have, at his word, and I hope the community at large will as well. Ralph has never violated the trust that I put in him, and I don't expect that to ever change. As the Managing Member of the Matt Ortt Companies, and on behalf of the management team, we stand fully behind Ralph's word and will continue to wait for all the facts to come out as the investigation proceeds."

The following is a statement from the Ocean Pines Board of Directors:

"This press release is being issued in response to a social media post by Mrs. Tiffany Knupp. At a meeting held on Monday afternoon with Mrs. Knupp and OPA Directors Colette Horn and Doug Parks, a discussion was had regarding the request for renaming the skate park. Mrs. Knupp held true to her desire for it to be renamed, but added that she had heard the Board was not in full agreement to support the request at this time. Directors Horn and Parks presented the idea of an annual award in Gavin Knupp's name that would be presented each year at the annual meeting in the same manner as the annual Sam Wilkerson award. The Directors promoted the idea of a partnership with the foundation she and her team created, and that the foundation would drive the selection criteria and details for the award. Mrs. Knupp agreed that it was a good idea and supported the notion that as an annual award her son's name and legacy would be preserved over time. At the conclusion of the meeting, she agreed that a motion for the annual award be put on the agenda for the upcoming board meeting, then hugged Director Horn and shook hands with Director Parks as she left. We felt that an agreement by all parties had been made at that point.

"The concern is the content of the social media comments posted by Mrs. Knupp. Given the discussion at the aforementioned meeting, the Board is both surprised and dismayed with the comments she made. First and foremost, the business relationship that the Association has with the Matt Ortt company has nothing to do with a decision to rename the skate park. The Board takes exception with the patently false and defamatory statement that '...We pay our dues and elect official to represent us, not to represent their friends that take them on expensive trips, pay their food and alcohol bill and use that to sway votes...!' Nothing could be further from the truth, as the Matt Ortt company does not oppose the renaming of the skatepark and has informed Ocean Pines on more than one occasion.

"The bulk of the remaining comments are opinion and while we may disagree with them, we recognize and respect these statements being made. With regard to the vile and disingenuous statement in the post 'Please kindly take the meaningless award and shove it up your asses,' the Board concludes that Mrs. Knupp is not interested in the award concept that she agreed to at the meeting on Monday. However, should she reconsider the issue at some point in the future, the Board is open to reconsider the idea of an annual award in her son's name."

Making a public statement bashing passionate supporters of the Gavin Knupp justice quest was a strange play last Saturday by Ocean Pines Association Board President Doug Parks. The comments in general showed questionable judgment, but what was intolerable was specifically connecting a potential rising assessment for Ocean Pines property owners to the ordeal if citizens did not begin to defend the yacht club. It's particularly interesting when assessments are proposed to be slightly declined in the proposed budget.

In trying to call out the supporters who have arguably from time to time gone too far with their online comments and personal attacks, Parks essentially did the same thing he claimed against the subjects of his comment. Parks did some of his own bullying when he maintained if community citizens didn't step in and stop the vitriol from some supporters of justice in the Gavin Knupp case it could hit them in the wallet. He said, "When will they stop? I can answer that – they won't. This is a call to all Ocean Pines Association members – raise your voices and be heard. We cannot let this vigilante group run roughshod over our community. By their actions and social media posts, they have demonstrated they care nothing about Ocean Pines and will go to whatever lengths it takes to disrupt our community and our livelihood.... Talk to your friends, talk to your neighbors and talk to other association members to let them know these situations are taking place and that this group is promoting a level of disruption to our community that at some point will affect us financially, which in turn will most likely lead to an increase in annual assessments."

This statement has done nothing but further incense the ardent Knupp supporters further and make the Ocean Pines Association Board look foolish. Through their attorney, the Knupp family simply said, "We see no reason to respond to a statement which confirms that the OPA elevates its own interests above those of the residents they were elected to serve. We remain focused on the Foundation and honoring Gavin's memory."

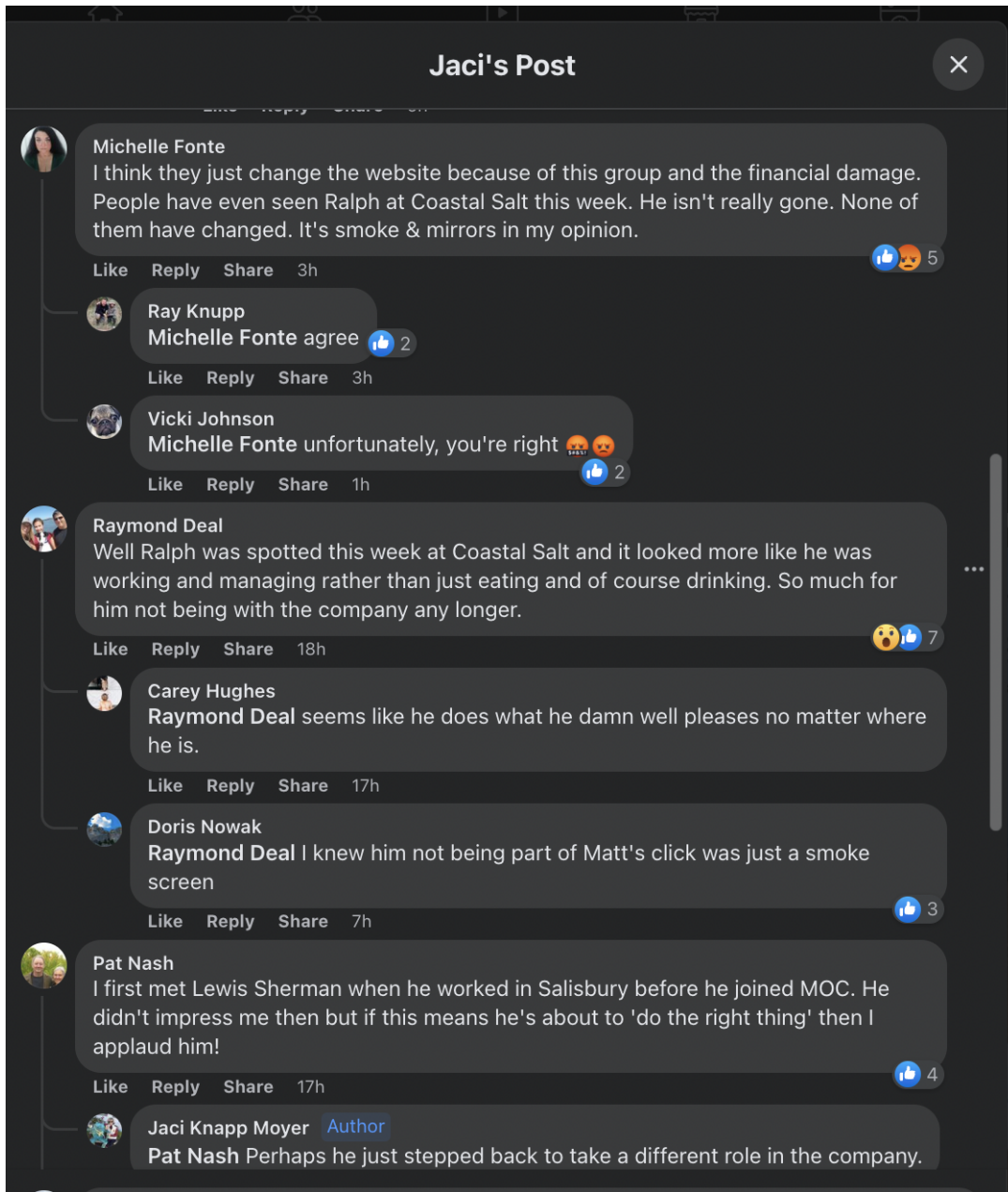


