★ July 11th 2022

- On their way home from their summer jobs, Gavin and Summer Knupp stopped on Grays Corner Rd. Gavin Knupp wanted to take a picture and video of a taxidermy buck's head. Gavin Knupp was then hit by a car that then sped off into the distance.
- Two cars were driving eastbound on the Grays Corner Rd. Tyler and Kearston were driving after being spotted at Ocean Pines Yacht Club, drinking at the bar.
- Summer and an unknown person called 911 while Summer Knupp tried giving
 CPR to her unresponsive brother on the road.
- o At 11:07 pm, Gavin was pronounced dead.

★ July 12th 2022

- The next day, Maryland State Police announced they were looking for a 2011 or 2012 dark Mercedes with damages to the driver's side mirror and headlight.
- The Knupp family was getting alerted that the car that hit Gavin, was spotted at the Ocean Pines Yacht Club.

★ July 15th 2022

 Ralph DeAngelus was contacted by police investigators. The reason for this 3 day delay was because of the family attorney becoming involved.

★ July 17th 2022


- Maryland State Police at 1:30 am impounded the black Mercedes from an area home.
 - Search and seizure warrant
 - Taken to MD State Police Berlin Barrack
- It was later to be found that the home that the car was impounded from was the residence of Ralph DeAngelus, his girlfriend Kearston Prey, and her son, Tyler Mailloux, who is 22.

★ July 18th 2022

- MD State Police Crash Team releases a statement detailing the crash and the vehicle involved
- Also stated car was found the 17th with DNA EVIDENCE FROM SCENE
 - Car's missing side mirror was found at the scene (matched serial number)

★ July 20th 2022

According to Eastern Shore Undercover, Matt Ortt released a statement at 8:05
 pm, attempting to calm people down about the incidents of the prior weeks.



- ★ July 22nd 2022
 - o Matt Ortt Companies issue statement in support of DeAngelus
- ★ July 23rd 2022
 - o Celebration of life in Ocean City @ 36th Street Beach
 - Hundreds in attendance
- ★ July 28th 2022
 - o DeAngelus and Ortt give statement on the incident and investigation
- ★ Late August 2022
 - Crash team investigators still looking for to follow up on leads and still looking for witnesses
 - According to police spokesperson Elena Russo
- ★ Late August September 2022
 - Gavin Knupp Foundation created
 - o Announced in late September along with first project it hoped to complete
- ★ September 9th 2022
 - o A protest was held outside of the State Attorney's Office to demand justice.
 - Still no update from state police
 - Referring people to 7/18 statement
- ★ September 2022

- Knupp family attorney releases statement to say they believe those responsible for Gavin's death will be held responsible, following meeting with SA
- ★ October 18th weekend 2022
 - Protest in front of Coastal Smokehouse, Coastal Salt, and Rum Shack over Matt
 Ortt Companies' response to potential/probable involvement of DeAngelus



- ★ November 4th 2022 (double check date)
 - Speed limits reduced on Gray's Corner between Route 589 and Riddle Lane following 2 hit and runs
 - Gavin Knupp & Terri Wattay (59, Berlin)
- ★ November 7th 2022
 - Matt Ortt Companies publicly cut ties w/ DeAngelus and his family members
 - Decision made in relation to Gavin's case
 - Ortt also apologized for some previous statements in support of DeAngelus
- ★ Week of November 17th 2022
 - Public disagreement between Tiffany Knupp & OPA
 - OPA wants to honor Gavin with a recurring scholarship
 - Foundation already has these
 - Tiffany wants skate park renamed in his honor

- Something she apparently received a promise of
- o Tiffany believes Matt Ortt Companies + others obstructing name change
- ★ December 17 2022 (see OPA regular board meeting minutes for this date)
 - o OPA President Statement
 - People calling for OPA to sever business relationship with Matt Ortt
 Company
 - Currently management firm for OPA's food and beverage operations
 - Contractual obligations
 - Currently no plan to change this relationship or end date for contract
 - Must consider financial interest and potential impact to any+all community members
- ★ Week of January 26th, 2023
 - o Coastal Smokehouse purchased by owners of Ropewalk
 - No confirmation if connected to case
- ★ February 3rd 2023
 - Tiffany posts pic on FaceBook of evidence someone almost ran over Gavin's memorial
 - Insinuates that it was Tyler or someone involved with him
- ★ February 15th 2023
 - Ocean City website addresses the signs so tourists can understand the situation
 - Also promotes foundation in the post
- ★ February 2023 (double check date)
 - After meeting with SA for Worcester County, family believe investigation moving in right direction
 - No new info that can be shared w/ public
- ★ March 18th 2023
 - The OPA Board of Directors had a meeting, discussing their describe "vengeance" behavior
 - "bullying of the business staff, bullying of children at school and threatening organizations, customers and OPA board members. Their actions demonstrated a move away from justice to a support for vengeance."

- 5/7 board member supported
 - Other 2 did not because of tone and tenor of the statement
- Woman blocked from the Search Committee because of her connection to Justice for Gavin
 - She was rejected 4-3

★ March 28th 2023

- Tiffany is interviewed on FM 98.1
 - Will be having their attorney deal with OPA's allegations
 - Called OPA kind of pathetic + said they are relentless in coming after her
 - Said her group not bullies, but community coming together around a family and make/be the change they want to see

★ April 1st 2023

- People in the Facebook group comment under a March 31 post claiming that
 DeAngelus had been seen at Coastal Salt that week
 - Said to have appeared to be working in a managerial role
 - Accusation that Matt Ortt Company has lied and not truly cut ties
- Using EIN posted by Ray in the Facebook group, the Gavin Knupp Foundation can be found in the IRS' tax exempt organization database (double check date)
 - No information other than the name is available in the database

★ April 2nd 2023

- Tiffany posts in Facebook group saying the OPA and its members are not the victims in this situation
 - Asks for group members to share screenshots of any+all statements and posts made by OPA members complaining about / attacking Justice for Gavin
