# Comments on European Strategy Building

- EU-wide RCE-Association make it easier to collaborate on and develop joint projects

# Comments on building an European RCE Association

- Structure follows action action follows vision
- Contents are more important than formal issues
- No need for weighty bureaucracy of further administrative coordination. But there is a need for better (formal) communication

## **Critical Aspects**

- Does the creation of permanent formal structures (more than thematic cooperation projects) actually promote common and regional activities?
- European RCE Association may undermine attempts to make links with RCE outside Europe
- It may cause duplications and misunderstanding because of two administrative groups (UNU-IAS and European Association)
  - More coordination at a global level rather than intervention at a local level

## **Affirmative Arguments**

- EU-wide RCE-Association make it easier to collaborate on and develop joint projects
- European RCE Cooperation on an informal and a formal level
  - Informal networking by email
  - Formal networking by regular meetings and joint projects
- RCE Collaboration in the frame of specific projects
- Using other European network
- It is very important to make visible the objectives and the activities of the RCE movement at

## **Strategies**

- The RCE-movement can only succeed if it emerges from spontaneous initiatives of highly motivated people; directing too much the selfdynamic of the movement is counterproductive.
- Expanding and founding collaboration via concrete projects
- Working on vision and reaching broad agreement
- Discussion and perhaps decisions at the European Conference in Munich

- Numbers
  - Big numbers in one country is a chance for collaboration.
- Scattering
